Reports:

ED Report-Bryan

- Enrollment:
 - All K-4 students are returning for 2019/20 year
 - 9 incoming kinder siblings- 7 open spots
 - 20 5th graders
 - 3 openings in the school under current configuration will most likely be 2/3/4 students
 - ED and Head Teacher will assess and add 3 spots to the roles in classes as they deem best for the 2019/20 school year.
 - Discussion of alternative configurations to accommodate 21+ more kids, creating a 6th classroom
 - Bryan will cost out addition of 21+ kids
- Attendance
 - Down from last year $\sim 82\%$
- Weather make up days
 - 900 hours of instruction
 - Because of high absentee rate, we must make up the two days that were missed for snow days.
 - Bryan will let student body/staff know that we will have to follow 509J makeup days.
- Physical Plant
 - Seismic Grant
 - To determine what level of funding we are actually at. Occupancy vs Life Safety Standards
 - Boiler Room
 - Two tanks on site need to be dealt with before concrete can be removed and further work done on the room
